## GREENWOOD LEFLORE HOSPITAL PLAIN LANGUAGE SUMMARY FOR FINANCIAL ASSISTANCE POLICY

It is the policy of Greenwood Leflore Hospital to provide medically necessary emergency care to all patients who present for treatment regardless of ability to pay. Greenwood Leflore Hospital has a financial assistance policy ("FAP"). As part of its mission, Greenwood Leflore Hospital offers financial assistance to patients who receive emergency and medically necessary services at Greenwood Leflore Hospital and who meet certain eligibility requirements under the hospital's FAP. In order to be eligible for financial assistance under the FAP, patients must meet all of the following requirements:

- 1. Be uninsured or underinsured;
- 2. Have a household income at or below 135% of the federal poverty level as published in the Federal Register on an annual basis;
- 3. Reside in the Hospital's Service Area, which is defined as Leflore County, Mississippi, and Carrol County, Mississippi; and
- 4. Require non-elective, medically necessary inpatient or outpatient care.

Patients who are eligible for assistance under the FAP may be eligible to receive discounted care as follows:

A FAP-eligible patient will not be charged more than the amount generally billed for emergency or other medically necessary services charged to patients who have insurance.
